MINUTES OF REGULAR MEETING
OF THE CITY COMMISSION OF THE CITY
OF LUFKIN, TEXAS, HELD JULY
1st, 1924.

Be it remembered that on this the 1st day of July, A. D. 1924, there came on and was held a regular meeting of the Honorable City Commission of the City of Lufkin, in the City Hall of said City, there being present and presiding the following officers: Kenneth Hoskins, Mayor Protem, (Sam H. Kerr, Mayor being absent), C. F. Becker, Commissioner of Ward No. 1, A. M. Walker, Commissioner of Ward No. 2, W. A. Behannon, Commissioner of Ward No. 3 and Kenneth Hoskins, Commissioner of Ward No. 4, C. N. Humason, City Manager, W. O. Seale, City Attorney and T. L. Dunn, City Secretary, when the following proceedings were had, to-wit:-

Minutes of former meetings read, and by move and second duly made and carried, were adopted.

An application of the State Highway Department, by the maintenance engineer in charge at Lufkin, made application to lease from the City, land near the old East Texas Depot for the purpose of erecting and maintaining storage tank for asphalt, was presented and after due consideration of same, it was moved by Kenneth Hoskins and seconded by W. A. Behannon that said application be not granted and that the city refuse to lease the property as aforesaid. Motion carried unanimously.

An ordinance entitled "AN ORDINANCE REQUIRING PERSONS OWNING OR HAVING IN POSSESSION COWS FROM WHICH MILK PRODUCTS ARE PRODUCED FOR SALE, TO REGISTER THEIR NAME AND ADDRESS IN A RECORD BOOK FOR THAT PURPOSE AT THE CITY SECRETARY'S OFFICE ANNUALLY AND OBTAIN A CERTIFICATE SHOWING SUCH REGISTRATION, MAKING VIOLATION THEREOF A MISDEMEANOR AND EACH DAY OF TWENTYFOUR HOURS A SEPARATE OFFENSE, AND CREATING AN EMERGENCY", was presented for passage and approval, and after due consideration of same and after having heard same read, it was moved by C. F. Becker, and seconded by A. M. Walker, that said ordinance be passed on first reading and that the rule requiring ordinance to be read at two stated meetings be suspended and such rules are suspended and this ordinance placed on second reading and final passage. The Mayor put the motion as above stated and requested all members of the City Commission who favored the passage of said ordinance to vote "Aye" and those opposed to same to vote "No"-The following members voted "Aye", Kenneth Hoskins, C.F.Becker, A.M.Walker, and W.A.Behannon. The following members voted "No"- None. The Mayor Protem declared the motion carried and the ordinance finally passed and adopted.

An Ordinance entitled "AN ORDINANCE APPOINTING THE MEMBERS OF THE BOARD OF EQUALIZATION IN AND FOR THE CITY OF LUFKIN, TEXAS, FOR THE YEAR, 1924" was presented for passage and approval on first reading. Said Ordinance was read to the City Commission after which ~~Kenneth~~ A.M. ~~Hoskins~~ made a motion to pass said ordinance on first reading which was seconded by C. F. Becker. Said Motion was put by the Mayor Pro tem and
