MINUTES OF REGULAR MEETING OF THE CITY
COMMISSION OF THE CITY OF LUFKIN,
TEXAS, HELD SEPT. 6th, 1938.

Be it remembered that on this the 6th day of September, A.D. 1938, there was begun and holden a regular meeting of the City Commission of the City of Lufkin, Texas, at the Municipal Office in said City with the following officers of the City present and presiding, to-wit:

The following proceedings were had, to-wit:

Joe McClendon and H. H. Melton, residents on Kiln Avenue were present and requested that a standard street light be installed on Kiln Avenue at its intersection with Falvey Avenue. After hearing the matter presented and same having been discussed, the City Manager was instructed to look into same, and if in his judgment such light is needed, to have one installed.

R.C.Musslewhite, Attorney for B. O. Watts, was present and presented a matter relative to City Taxes for the year 1937, owed by the said B. O. Watts, and asked that penalties, interest and costs be waived for the reason that the property on which such tax is due was in litigation at the time said taxes were due and payable, but that now such litigation was settled and said Watts was ready to pay the taxes. After hearing the matter presented and having considered the same, on motion by J.E.Jay, seconded by J. B. Perry, it was unanimously carried that such penalties, interest and costs be waived, and the City Tax Collector instructed to issue proper tax receipt upon payment of the taxes as aforesaid.

C. D. Collins, (Col) was present and made application for a permit to build a filling station on Lot 9, Block 5 of the North Lufkin Addition to the City of Lufkin, Texas. Such application having been heard and considered, it was moved by W.D.Winston, Jr. and seconded by J. E. Jay that a permit be granted to the said C.D.Collins, (COL) to build a filling station on Lot No. 9, Block No. 5 of the North Lufkin Addition to the City of Lufkin, Texas, provided that no objection is made by property owners in the vicinity. The motion carried unanimously.
