If on Paved Street and paving in cut or broken an additional charge, from the Dirt Street charge, of \$20.00 shall be made, Making \$45.00 when paving in cut or broken. Where sidewalk in the business district is cut or broken a charge of \$15.00 shall be made, and where sidewalk is cut or broken in the residential district a charge of \$5.00 shall be made. All Voted "Yes"

Motion carried to pay all bill as presented by Secretary. All voted "Yes" Motion carried to Adjourn.
