

MINUTES OF A CALLED MEETING OF THE CITY COMMISSION OF THE CITY  
OF LUFKIN, TEXAS HELD ON JULY 8, 1940 AT 7:30 P.M.

The City Commission of the City of Lufkin, Texas convened in a called meeting on July 8, 1940 at 7:30 p.m. at the regular meeting place with the following members present:

and the following absent: NED SHANDS, JR. CITY ATTORNEY, constituting quorum when the following proceedings were had:

1. Miss Fortenberry, the district supervisor of Housekeeping Aid was present and gave a general outline of what she is doing and stated that they needed larger and more convenient quarters for their training work. The Council requested the Mayor and

City Manager to confer with the County Judge and see if the County would bear the expense of repairing and improving the building that was being used. In as much as the City is furnishing the property and the County has been paying nothing in the way of rent, the Council felt that they could do nothing about the matter. In the event that no arrangements could be made to repair the building, the mayor and city manager were authorized to rent a building suitable with the County going in with them on a fifty-fifty basis.

2. Jim Hale was present and requested the Council to reconsider his application for a taxicab permit, and upon motion of Commissioner W. D. Winston, Jr., seconded by Commissioner J. E. Jay, it was moved and carried to reconsider the applications of Jim Hale and Vernon Bradford. The Secretary was ordered to publish the required notice of hearing.

3. Upon motion of Commissioner G. E. Barington, seconded by Commissioner W. D. Winston, Jr., all accounts for the month of June were read, approved and ordered paid.




5. On motion of Commissioner G. E. Barington, seconded by Commissioner R. E. Melvin, it was moved and carried that the valuation of Lot 5, Block 10 owned by J. H. Purvis be placed at \$4,000.00 provided all taxes due are paid promptly on this basis.
