

MINUTES OF SPECIAL MEETING OF THE CITY COMMISSION OF THE CITY OF LUFKIN, TEXAS, HELD ON THE 19th DAY OF APRIL, 1967, AT 5:00 P.M.

On the 19th day of April, 1967, the City Commission of the City of Lufkin, Texas, convened in special meeting in the regular meeting place of said City, with the following members thereof, to-wit:

being present, constituting a quorum, when the following business was transacted:

1. Meeting opened with prayer by Commissioner Byron McNeil.
2. Mayor stated special meeting was called for the purpose only of considering settlement of William George Produce remodeling project.

Mr. Murphy George, representing William George Produce Co., was present and stated he was very desirous of settling this issue since he, like all other citizens of Lufkin, wanted the underpass and widening project on Frank and Dozier as well as Angelina Street started. He stated he had received bid from Thomas and Thompson Construction Co. covering asphalt paving that was not included in original bid of \$26,790.00 covering remodeling of their building and he desired this paving be included in the settlement. Commissioner Byron McNeil asked Mr. George if his Company would pay half of the paving cost of \$2,340.00. Mr. George stated he did not feel that his Company could participate in this cost since his company would sustain other damages that have not been enumerated.

Mr. Jerry Hill, Architect, who was present stated that the original bid of \$26,790.00 had a contingency fund included of \$200.00 that could be deducted leaving the original bid \$26,590.00. Mr. Hill further stated a supervisory fee of 2% of this amount should be added making the total \$27,121.80; and this figure, plus the estimate of \$2,340.00 additional for paving, making a grand total of \$29,461.80.

Mr. George stated this amount would be acceptable to his Company. Commissioner Basil E. Atkinson, Jr., M.D. made motion that settlement be made with William George Produce Co. in the amount of \$29,461.80. Motion seconded by Commissioner Carl Liese and the following vote recorded.

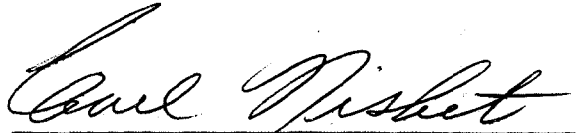
