Minutes of the City Council, meeting April 15, 1915.

BE IT REMEMBERED that on this the 15th day of April, A.D. 1915, there came on and was held a "SPECIAL CALL" session of the City Council, said Call Meeting being held pursuant to a call of the Mayor of said City, in the Council Chambers of said City, there being present and presiding the following officers:

Dr. T.A. Taylor, Alderman,

Dr. B.F. Gibson, "

I.D. Fairchild, "

Sam H. Kerr, "

When the following proceedings among others were had, to-wit:

City Secretary L.H. Gray being absent, a motion was made by Alderman Kerr and seconded by Alderman Gibson, all aldermen present voting aye, that G.T. Cross be elected secretary pro tempore to make minutes of the proceedings and act in the meeting.

On motion of Alderman Kerr and seconded by Alderman Taylor, all aldermen voting aye, a Resolution was passed, titled: "Resolution Declaring the Result of the General Election Held within and for the City of Lufkin, Texas, on the 6th day of April, A.D. 1915."

On motion of Alderman Gibson and seconded by Alderman Kerr, all aldermen and Mayor voting aye, there was adopted a Resolution in Memory of the late Alderman Albert J. Glenn; the said Resolution being inserted in the records of the Council.

The Mayor, with the approval of the Council, appointed Alderman Taylor and Alderman Gibson as a committee to check up the reports of the different officers, as follows: Treasurer, Assessor & Collector, Water Commissioner, Street Commissioner, and City Secretary; and make report on same.

On motion of Alderman Kerr and seconded by Alderman Gibson, all aldermen voting aye, there was approved the City Engineer's Progress Estimates Nos. 1 and 2 on Special Street Improvement Funds Nos. 6 and 7, in favor of C.M. McConnico.

A motion was made by Alderman Taylor and seconded by Alderman Kerr, all aldermen voting aye, That ~~the~~ Assessment on Street Paving be Corrected as follows: Subdivision F, Lot 1, Block 4, against Jake Markus....\$101.71; Lot 12, Block 4, against H. & J. Abram....\$82.20 Lot 11, Block 4, against D.A. Singleton..\$116.75.

Bills and accounts were allowed, as read and approved.

On motion of Alderman Kerr and seconded by Alderman Gibson, all ~~the~~ aldermen voting aye, an ordinance was passed titled: "An Ordinance Authorizing the City Engineer to Issue a Permit for the Erection of an Airdome."

There being no further business a motion was carried to adjourn.
