

MINUTES OF A CALL MEETING OF THE CITY
COMMISSION OF THE CITY OF LUFKIN,
TEXAS, HELD SEPT. 9th, 1935.

Be it remembered that on this the 9th day of September, A.D. 1935, there was begun and holden a call meeting of the City Commission of the City of Lufkin, Texas, at the Municipal Office in said City, with the following officers present and presiding, to-wit:-

The following proceedings were had, to-wit:-

-----oOo-----

Eli Hawkins appeared before the City Commission and presented a plan for the city to purchase a site for an air port. He was listened to with interest, and was instructed to determine if the necessary land could be secured at a reasonable price and to again report his findings.

-----oOo-----

A Mr. Slaughter, who is retailing bread to the retail trade in the City limits was present, stating that he had been advised by City Authorities that in the peddling of bread he was violating a City Ordinance and had been requested to cease. He stated that his method of retailing such bread was not in violation of the City Ordinance. However, the City Commssion was not fully convinced that he was not violating such ordinance and stated unanimously that such ordinance should be enforced by the proper city authorities, and so instructed.

Mrs. I. D. Fairchild appeared regarding the matter of re-wiring a building in the brick fire limits that had been cut off by the Light Company, and which cutting back on had been denied by the City Electrical Inspector for the reason that it would be in violation of the City Electrical Ordinance. After hearing Mrs. Fairchild discuss the matter and having discussed the question themselves the City Commission passed same without granting permissssion for ~~cutting~~ the lights in again until the wiring in said building was made to conform to the City Electrical Ordinance.

A resolution providing for the execution of a contract with C.D. Jessup, Jr. of Houston, Texas, for the collection of City Delinquent taxes was presented for passage and approval. The same having been

read to the City Commission and same being duly discussed, it was moved by W. O. Greene, and seconded by W. A. Abney, that said resolution be passed and approved. The following is the recorded vote on the motion: "Ayes"- Kenneth Hoskins, W.O. Greene, Louis Hicks, D.A. Campbell and W. A. Abney. "Nees"- None+ Whereupon the Mayor declared the motion carried and the resolution passed and approved.

The question of allowing a discount on City Advalorem Taxes for the year 1935, was discussed, after which on motion made by D.A. Campbell, seconded by Louis Hicks, it was unanimously carried to allow discounts as follows:-

If paid in October 1935, allow 3% discount.

If paid in November, 1935, allow a 2% discount.

If paid in December, 1935, allow 1% discount.

No discounts if paid in January 1936, and it is further ordered that regular penalties be added February 1st, 1936.

A further discussion of the C. C. Vinson's request for permission to erect flood lights on Lufkin Avenue, same to be erected on Esplanade on Lufkin Avenue fronting his buildings, was had, after which it was moved by D.A. Campbell and seconded by W. O. Greene, that such permission be granted. The motion carried unanimously.

City Tax Collector presented the completed City Tax Rolls of the City for the year 1935, and requested that they be examined and approved. They were examined and on motion made by W. O. Greene, Seconded by D.A. Campbell, they were approved by the unanimous vote of the City Commission, by affixing their signatures to said rolls.

Accounts and bills due the city to various parties, firms and corporations were presented for payment and it appearing that such of said bills as had been audited and approved by the City Manager, should be paid, on motion duly made and carried they were allowed.

There being no further business to come before the meeting, on motion duly made and carried, it adjourned.
