ing business was transacted:

1. The meeting was opened with a prayer by Mayor Woodrow W. Scott.

2. The minutes of April 3, were read and approved.

3. A committee headed by Mrs. Anderson, Mr. Zeagler and Mr. Anderson, Mr. Zeagler and Mr. Anderson, appeared before the commission in the interest of the beautification of the City. They discussed garbage containers and requested that all garbage containers have water tight lids and that they be of uniform size as provided by ordinance now in force. Also, they requested that all oil drums used for garbage be also eliminated because they were unsightly and contained no lids. They also discussed cleaning vacant lots in the City. The City Commission agreed to co-operate in this movement in every way possible.

4. Mr. J. B. Nolan, a resident of Zeagler Street appeared with a committee and protested the parking of cars on both sides of Zeagler Street by school students. He stated that since the parking of cars was prohibited on both sides of the street in front of the Old Senior High School that students just moved over and parked their cars on Zeagler Street, causing confusion, conjestion, and a blocked street. It was agreed that this problem would be looked into immediately and all the radief possible would be given. 5. Johnny Frank Medford appeared before the Commission with a representive of a company which manufactures Commode Valves and said that such company was looking for a new location to move its factory and wanted to know what inducement the City of Lufkin had to offer for such an industry. He was refered to the Industrial Committee of the Chamber of Commerce for more detailed informatic

6. Bids were opened for the paving on Lufkin Avenue between Chestnut Street and Timberland Drive and Moore Construction Company bid \$23,710.05, this bid being the low and best bid on the porject, such bid was accepted.

7. Mr. Turner of the Engineering firm of Freeze, Nicholas & Turner appeared before the commission and discussed the plan for increasing the water supply and the cost of bringing more water into town. He was instructed to proceed with the plan B as outlined by his engineer.

8. Zone change from "A" district to "H" district was granted Marvin Stubblefield on a Lot and Parcel of land on U. S. Highway 69 North West of Texas Foundries. Also zone change was granted Dr. B. D. Rhodes and Dr. Ned Barrett from "A" district to "E" district on a Lot and Parcel on the South side of Ellis Avenue.

9. The commission voted to confirm the sale to Clyde Jordan for \$1,100.00 of the old 2-story house at 318 Shepherd Avenue known as the Satterfield property.

10. It was voted to request the State Highway Department to make a re-survey of traffic on Timberland Drive, particularly with references to speed of vehicles, and report the recommendations to the City as marly possible.

11. It was agreed to install a traffic light at the inter-
