  - 1. The meeting was opened with prayer by Mayor Woodrow W. Scott.
  - 2. The minutes of the regular meeting of February 19, of the regular meeting of March 5, and of the called meeting of March 7, were read and approved.
  - 3. Darrell Yates came before the Commission and requested that the City lay a larger water line outside the City Limits on the Old Nacogdoches Highway. He representated that there were a number of parties who would connect to such line if it were available. He was advised that the City could not spend money outside the City Limits for the installation of a water line, and if such a water line was laid, it would have to be done by the folks who would use same, and without cost to the City.
  - 4. Mr. Jack Fleckner headed a delegation in the interest of widening South First Street from Shepherd Avenue to U. S. 59. They were advised by the City Manager that the City had a date on March 28th with Mr. Greer, State Highway engineer, in Austin, relative to the widening of South First Street. The Committee was advised that the City was using every effort to widen South First Street, and also to obtain State aid in such project.
  - Representaives from the Lufkin Telephone Exchange appeared before the Commission in the interest of increased telephone rates but the hearing was postponed because of the absence of Commissioner Granville Wright.

- 6. The City Commission confirmed the purchase of a share of stock in the Country Club for the use and benefit of the City Manager.
- 7. Bills for the month of February were approved and ordered paid.
- 8. An ordinance regulating traffic on Chestnut Street between Timberland Drive and Cornegay Street was passed on first reading.
- 9. The City Manager was instructed to contact county officials to see if they contemplated buying a radio set for the use of the sheriff's department or whether they wanted to continue such radio services from the City of Lufkin Police Department radio station, upon a rental basis.
- 10. It was agreed that Mayor Scott would contact Southern Pacific Railroad relative to getting one of their discarded steam engines to be kept in the City Park as a relic and memento of steam engine days.

11. There being no further business to come before the Commission the meeting adjourned.
