- On Motion of Com. Nerren, and Seconded by Com. Brittain, all voting "Yea." Commissioner Elsyn Gipson was appointed Mayor-Pro. Tem.
- On motion of Com. Collins, Seconded by Com. Gipson, all voting "Yea." the Commission voted to make no changes in major policies of previous commission, at this time.
- The Commission agreed to pay all bill s for month of March as presented. Motion-Nerren, Seconded-Brittain, All voting "Yea."
- The Commission agreed to hold weekly council meetings until further notice. Special Meetings to be held 2nd, 4th and 5th Tuesday Nights at 7:30 P. M. Motion-Collins, Seconded Nerren. All voting "Yea."
