McConnico to do further work on the streets of this City under the direction of the Mayor and each alderman when the work affects different wards, said work to be done under the following schedule of prices:

Team and drivers @ \$5.00 per day.

Extra men from \$1.00 to \$2.50 per day.

10% for supervising the work.

McConnico, To furnish all tools and pay for blacksmith bills, and repairs.  
The Council reserves the right to stop this work any day.
