- 2. The bills as presented were approved for payment as was the final payment of \$3,000.00, plus interest, on the street sweeper note, motion by Commissioner Stegall, second by Commissioner Snell.
- 3. Zone change request as submitted by J. H. Purvis approved to be advertised, motion Commissioner Snell, second by Commissioner Stegall.
- 4 The Commission deferred action on an application for a taxicab license for Roy Bazzoon as presented by his lawyer Thomas J. Moroney, Jr. Mr. Sumner Williams, representing interested parties, opposed the issuance of such license. Final hearing was promised by the Commission on March 4th.
- 5 No action was taken on a request by George K. DuPay, representing Ed Kinnerly, that the Commission withdraw the ordinance authorizing a zone change granted at the request of R. S. Gipson.
- 6. Commissioner Stegall made a motion that the zoning ordinance be amended to make mandatory the notification by letter, registered with return receipt, of all property owners within 200 ft. of a proposed zone change who do not sign with approval the proposed zone change.
