AN ORDINANCE APPROVING AND ADOPTING A BUDGET FOR THE CITY OF LUFKIN, TEXAS for the Fiscal Year ended MARCH 31, 1943, AND FIXING THE EFFECTIVE DATE HEREOF

WHEREAS, in accordance with the laws of the State of Texas and the Charter of the City of Lufkin, the City Manager of said City prepared and submitted to the City Commission of said City, a proposed budget for the fiscal year ended March 31, 1943; and,

WHEREAS, a Public Hearing was had on the 13th day of august, a. D. 1942, pursuant to Notice published in the Lufkin Daily News, a daily newspaper published in Lufkin, angelina County, Texas, as shown in the affidavit of the Publisher thereof which accompanies this Ordinance; and,

MHEREAS, the City Commission, at said Public Hearing, the proposed was discussed and sufficient time was given to hearing protests and objections, oral or written, to items in the budget and to omissions therefrom:
