MINUTES OF THE REGULAR MEETING OF THE CITY COMMISSION OF THE CITY OF LUFKIN, HELD FEBRUARY 17, 1953, AT 7:30 P. M.

On this the 17th day of February A. D. 1953, The City Commission of the City of Lufkin, Texas convened in Regular Session, at its Regular Meeting place in, said City, with the following members thereof being present:

A Quorum being present. The following business was transacted.

The minutes of the regular meeting held February 3rd, 1953 were read and approved.

- A group of negro citizens, with E. E. Cleaver, as spokesman appeared before the Commission with detailed plans for a Recreation Program for Jones Lake Park. They asked that the City erect a Recreation Building 30 x 30 feet at Jones Lake, and appropriate funds to pay supervisor and hostess for this area, and they, through their civic clubs and Negro Chamber of Commerce would raise funds to buy the necessary equipment for this program. On motion of Commissioner Stegall and seconded by Commissioner Nerren, all voting "yea". The Commission voted to erect building as described, At a cost of about \$3550.00, this estimate prepared by city manager. On motion of Commissioner Nerren and seconded by Commissioner Brittain, all voting "yea". The Commission voted to appropriate the sum of \$1500.00 per anum for hostess and supervision of this program.
- The Commission voted unanimously to pay all bills for month of January, 1953 as presented.
- Mon motion of Commissioner Stegall and seconded by Commissioner Nerren. All voting "yea" the Commission authorized the City Manager to take bids on reworking and lowering #3 and #5 water wells. The Commission also authorized the City Manager to take bids on a 750 Gallon Booster Pumper for the Fire Department.
- 5 The Council authorized the expenditure of \$50.40 to the Firemen's Relief Fund to reinstate Jessie Ray and G. A. Gilbert.
- On motion of Commissioner Nergen and Seconded by Commissioner Stegall, the Council passed ordinance calling an Election for First Tuesday in April, 1953, same being April 7th, 1953 for the purpose of electing a Mayor, a Commissioner from Ward 1, and a Commissioner from Ward 3.

The Council approved schedule of salary increase of \$15.00 to \$25.00, as prepared by the City Manager, for salaried personnel, except City Hall Employees. Schedule attached hereto.

There being no further business, the Commission adjourned.
