MINUTES OF A REGULAR MEETING OF THE CITY COMMISSION OF THE CITY OF LUFKIN? TEXAS, HELD July 5th, 1932.

Be it remembered that on this the 5th day of July, A.D. 1932, there was begun and holden a regular meeting of the City Commission in and for the City of Lufkin, Texas, at the Minicipal Office in said City, with the following officers of the City Present and presiding, to; wit:-

M. M. Jones, Commissioner of Ward No. 3 was absent. The following proceedings were had, towit:-

Minutes of former meetings, that is meetings held during the month of June, were read, and on motion duly made and carried, were approved as read.

Mr. Nolan C. Phillips, auditor, was present and presented for approval his report of the audit of the City records for the fiscal year ending March 31st, 1932, which said report had heretofore been refused of acceptance because of errors in same, but which now was claimed to be correct by said Auditor. After examiningsaid report and discussing same with the Auditor, it appeared that same was now correct and in shape to be accepted. It was therefore moved by W.A. Abney and seconded by W. O. Greene, that said report be accepted and that check in the sum of \$175.00 be issued in payment of same. Motion carried.

The City having heretofore called for bids for the purpose of selecting a deposity for city funds for the ensuing two years, the only bid received was one from The First State Bank & Trust Company of Lufkin, Texas, which was fax a bid to pay the city 2% on the average daily balances of the City each month. After consideraing said bid, it was moved by C. A. Burke and seconded by W.A. Abney that said bid be accepted, and that said The First State Bank &BTrust Company be selected as Deposityry for City Funds for the two years beginning april 1stm 1932 and ending with March 31st, 1934. Motion carried.

Mr. R. W. Edwards appeared before the City Commission and registered a complaint regarding treatment of himself by one of the City Policemen, Mr. W. C. Turner; the said Edwards claiming that he was arrested and roughly handled without cause and that he felt like he had been or would suffer injury relating to his reputation as a good citizen, and insisted that something be done whereby no stain would be left upon has character or reputation. Evidence was heard from both sides, that is Mr. Edwards side and also Mr. W.C. Turner was present and made a statement regarding the affair. All evidence being heard, Mr. Edwards was assured that no intention was had that would in any way reflect on his character or reputation as a citizen, and that a mistake was made, since he was inocent of any crime or misconduct, and that this City Commission would assure any personor persons that he the said R.W. Edwards was entirely exonerated of any misconduct whatsoever.

Heretofore in October 19#29, the City of Lufkin instituted condemnation proceedings against Mr & Mrs A E Percy for the purpose of acquiring right of way to widen Sayers Street in order that same could be paved.

In the trial of the case a Jury found in favor of the said A.E. Percy in the sum of \$312.50. From this verdict the said A.E. Percy and wife appealed, since which time the case has been pending in the court. Now the said A.E. Percy and wife through their Attorney, agree to accept the verdict of the Jury as heretofore rendered and ask that said amount of \$312.50 be paid to them in full settlement of the property condemned for street purposes. W.Q. Greene made a motion which was seconed by C.A. Burke that said amount would be paid to the said A.E. Percy on condition that the suit be dismissed at

All accounts and bills due by the City to various parties, firms and corporations were presented for payment and it appearing that such of said bills as had been properly audited and approved for payment by the City Manager shold be paid, on motion duly made and carried same were allowed.

the cost of the said A.E. Percy. The motion carried unanimously.

There being no further business to come before the meeting, on motion duly made and carried, same adjourned.
