The following business was had to wit:-

It was moved by Alderman Price and seconded by Alderman Davis that all Ordinances here-tofore passed pertaining to the \$25,000 imprevement warrants, be repealed and that City Attorney be and he is hereby instructed to prepare an ordinance appealing nances. All Aldermen voting "AYE"

It was moved by Alderman Price and seconded by Alderman said ordinances.

Davis that the City Attorny be and he is hereby instructed to draft resolutions authorizing and directing Mayor and City Sec-retary not to execute and more refunding warrants to take up the out-standing scrip under the \$ 14,000 ordinance heretofore adopted. All Aldermen voting AYE"

Movem by Alderman Davis and seconded by Alderman Price that the City Attorney be and he is hereby instructed to to draft an ordinance compelling livery stables to clean up their premises and haul off the refuse every daym also compel all over ground cisterns to be screened thus eliminating all egress and ingress of flies and other insects. All aldermen voting "AYE"

In compliance with the request of the Council in the preceding chapter, Attorney Feagin presented an ordinance entitled, " AN ORD-DINANCE PROVIDING FOR THE REGULATION OF THE USE OF OVER GROUND TOILETS AND PRIVIES, PROVIDINGFOR THE SCREENING THEREOF, PROVIDING FOR THE CLEANING OF THE LIVERY STABLES AND THE HAULING OF THE REFUSE THERE)OF DAILY, AND PROVIDING FOR A PENALTY ", said ordinance being designzted as Ordinance No. 110 of the City of Lufkin, TEXAS.

On being put to a vote, all Aldermen voted "AYE".

Attorny Feagin also presented an Ordinance entitled, "AN ORDINANCE AUTHORIZING AND GALLING AN ELECTION TO BE HELD IN THE CITY OF LUFKIN, TEXAS, ON THE FIRST THESDAY IN APRIL 1916, FOR THE PURPOSE OF ELECTING TWO ALDERMEN, AND PROVIDING FOR NOTICE OF SAID ELECTION AND APPOINTING ELECTION OFFICERS"/ being ordinance No. 120 of the City of Lufkin, TEXAS. On being put to

a vote, all Aldermen voted AYE.

It was moved by Alderman Price and Seconded by Alderman
Behanon that an Ordinance entitled, "AN ORDINANCE PROVIDING FOR
THE FUNDING OF THE EXISTING DEBT OF THE CITY OF LUFKIN, TEXAS, IN THE SUM OF \$30,000 BY CANCELL ING THE EVIDENCE THEREOF AND ISSUEING TO THE HOLDER TREASURY WARRANTS WITH INTEREST CUPONS ", b ing ordinance no. 121 of the City of Lufkin, TEXAS. All Aldermen present voted for and in favor of the adoption of the Ordinance as read.

There being no further business to come before the Council, Alderman Price moved and Alderman Behanon seconded that the Council ad All Aldermen voting "AYE.
