THE PURPOSE of this meeting as stated by the Mayor, being a continuation of the call meeting of July 14th, 1928 and which was continued to July 16th, 1928, for the purpose of hearing evidence, if any, as to the enhancement of property values that will accrue, if any, to the owners of property abutting on those portions of the streets and avenues embraced in the City's paving program, which said streets and avenues are fully described in the minutes hereof of July 14th, A.D. 1928, and was for the purpose of hearing any protests or objections by property owners, and agents or attorneys, or persons interested therein, against the improving of said streets and avenues.

No one appearing at this meeting at all for the purpose of protesting or objecting to the street paving program, nor to the issuance of improvement assessment certificates against the owners of property abutting on said streets and avenues for such street improvement.

The ordinances levying the assessment against the various property owners on the streets and avenues embraced in the City's paving program as described herein on July 14, A.D. 1928, was read and passed on first reading.
