

MINUTES OF THE REGULAR MEETING
OF THE CITY COMMISSION OF THE CITY OF LUFKIN,
TEXAS, HELD APRIL 6TH, 1920 .

Be it remembered that on this the 6th day of April, A. D. 1920, there was begun and holden a regular term of the City Commission of the City of Lufkin, Texas, in said City at the Municipal Office thereof. Present and presiding the Hon G. A. Kelley, Mayor, S. R. Parker, Commissioner Ward No. 1, E. E. Woods, Commissioner Ward No. 2, W. B. Treadwell, Commissioner of Ward No. 4, L. Mitchell, City Manager, and T. L. Dunn, City Secretary, when the following proceedings were had, to-wit:-

Minutes of previous regular meeting and Special Meetings read before the Commission, and by move and second were approved and adopted.

AN ORDINANCE.

Whereas, the office of City Commission of Ward No. 3 of the City of Lufkin, Texas, has been declared vacant for the reason of the removal from the City, C. B. Edwards, the duly elected Commissioner from said Ward No. 3.

Whereas, the City Commission of the City of Lufkin, Texas, is in situation to fill the vacancy in such office by an election.

Therefore, be it ordained by the City Commission of the City of Lufkin, Texas;

That an election be held within and for the City of Lufkin, Texas, on the 17th day of April, A. D. 1920 for the purpose of electing a Commissioner from Ward No. 3 in and for the City of Lufkin, Texas. That said election shall be held in conformity with the charter of the City of Lufkin, Texas, and general laws of the State of Texas applicable thereto.

All qualified electors are qualified to vote at such election. The Ballot for said election shall have written or printed on it the words "Official Ballot" and the names of the candidates.

Should any candidate fail to receive a majority of the legal votes at said election, the City Commission shall immediately order a special election to be held not later than ten (10) days not more than twenty (20) days after the result of said election has been declared, at which other election the names only of the two candidates receiving the highest number of votes at the first election shall be printed on the ballot and

and submitted to the qualified voters. The candidate receiving the majority of the votes shall be declared legally elected.

The following are hereby appointed as acting judges at said election, D. A. Singleton, Sam H. Kerr, H. P. Davis and P. M. Albritton.

Notice of this election shall be given by the Mayor by posting a copy of this ordinance, certified under the had of the City Secretary in three (3) public places within said City, one of which shall be at the Fire Station door for ten (10) days prior to said election.

E. E. Woods made a motion to pass and approve the above ordinance on its second reading, and S. R. Parker seconded said Motion. The Mayor then put the question and instructed all those Commissioners favoring the passage of said ordinance to vote "Aye", and those Commissioners opposing the passage of said ordinance to vote "No". The following Commissioners voted "Aye"- E. E. Woods, S. R. Parker, W. B. Treadwell and G. A. Kelley, Mayor. The following Commissioners voted "No"- None. The Mayor then declared the motion carried and the ordinance aforesaid passed and approved on its second reading.

A petition, dated January 3rd, 1914, signed by John L. Reese and twenty-one others, praying that a public street be opened up, beginning at E. B. Robb's residence; thence South to Manton road, going across the land belonging to E.B.Robb, S.H.Townsend, Mrs. Ella Clingman, Mrs. Warren, Battles, Mr. Ed Harrell, C.C. and W.H.Hicks, Tom Hudgens, John Reece, Dug Tucker, J.F.Price, P.E.Lindsey, E.F.Dunlap and J.D.Adams, also Mrs. Arena Nesbert. Said petition also praying that a public street be opened up, beginning at the East line of the City limits near Hartman's residence and thence west to Chesnutt street. Land across which, and adjacent to said proposed street is as follows: W. R. Fuller, E.F.Dunlap, Mr. Yates, Mrs. Odum, Mrs. Elliott, Mrs. Arena Nesbert J. D. Adams, John McCall and others. After hearing said petition and argument of parties interested in the establishment of said streets, it was moved by Commissioner Parker and seconded by Commissioner Treadwell, which said motion duly carried, that the City Manager be instructed to secure the services of J. F. Davis, and go

with him, and survey said proposed streets and to make a plat of same and also to secure the names of all parties that would be affected by the establishment of said streets; ascertain their attitude toward the establishment of same; what concessions they would make toward the establishment of said streets, and any other data that would be to the interest of the city.

All accounts and bills due by the City to various parties, firms or corporations were presented for payment, and it appearing that said accounts or bills had been examined and approved by the City Manager as provided, by move and second duly made and carried, same were allowed and the city Secretary ordered to issue City Script in payment of same.

The question of fixing salaries of city Employees for the fiscal year, beginning April 1st, 1920, was discussed, and by move and second duly made and carried, were fixed as follows:-

L. Mitchell, City Manager- raised from \$200.00 to \$250.00 per month.
T.L.Dunn, City Secretary,-raised from \$125.00 to \$150.00 per Month.
Tom Russell, Chief Pumper- raised from \$110.00 to \$125.00 per month.
Jess Brittain, Ass't " - raised from \$70.00 to \$85.00 per month.
Edgar Jones, Fireman No 1- raised from \$90.00 to \$100.00 per month.
Gena Walker, Stenog. raised from \$_____ to \$75.00 per month.

There being no other business to come before the meeting, by move and second duly made and carried, adjournment was taken.
