## MINUTES OF REGULAR MEETING OF THE CITY COMMISSION OF THE CITY OF LUFKIN. TEXAS. HELD AUGUST 5th. 1984.

Be it remembered that on this the 5th day of August, A. D. 1924, there no becall some came on and was held a regular meeting of the Henorable City Commission of the City of Lufkin, in the City Hall of said City, there being present and presiding the following officers: Sam H. Kerr, Mayor, C. F. Becker, Commissioner of Ward No. 1, A. M. Walker, Commissioner of Ward No. 2, W. A. Behannon, Commissioner of Ward No. 3, and Kenneth Hoskins, Commissioner of Ward No. 4, and C. N. Humason, City Manager, W. O. Seale, City Attorney and T. L. Dunn, City Secretary, when the following proceedings were had, to-wit:-

Minutes of former meetings, were read, and by move and second duly made and carried were approved.

A proposition was presented to the City Commission by Mr. H. W. Ragland, representing Mr. F. A. Larkin, to sell to the City Lot 8 in Block 1 of the West End Addition, for street purposes. After consideration of the matter, by move made by G. F. Becker and seconded by Kenneth Hoskins, which motion carried unsnimously, the matter was tableed.

The question of leasing to W. L. Jones what is known as the Old Gity Reservoir was brought up for consideration, and after discussing the matter A. M. Walker made a motion which was seconded by Kenneth Hoskins, to authorize the Mayor to execute lease by and between the Gity and W. L. Jones. The Motion carried unanimously.

It appearing to the City Commission that the City is in need of additional Fire Apparatus in the way of a straight chemical engine, a move was made by Kenneth Hoskins and seconded by C. F. Becker, to empower the City Manager to purchase a two tank chemical engine for the Fire Department. The Motion carried unanimously.

The Pollowing ordinance was presented for passage and approval, viz:

"AN ORDINANCE MAKING IT UNLAWFUL FOR ANY PERSON, FIRM OR CORPORATION TO TRANSPORT GASOLENED OR OTHER INFLAMABLE VOLATILE OILS OR LIQUIDS TO RETAIL FILLING STATIONS IN CONTAINERS OTHER THAN STEEL TANKS ON VEHICLES EQUIPPED WITH RUBBER TIRES, TANKS MUST BE PROVIDED WITH APPROVED HOSE ATTACHMENTS NOT EXCEEDING EIGHT FEET IN LENGTH AND EQUIPPED WITH GROUND, KEY SHUT-OFF COCKS, AND PROVIDING ALL UNDER GROUND FILLING STATION STORAGE TANKS MUST BE FILLED BY THE USE OF SUCH HOSE, FIXING PENALTY FOR VIOLATION THEREOF, AND PROVIDING EMERGENCY".

Commissioner W. A. Behannon moved that the ordinance be placed on its first reading; seconded by Commissioner A. M. Walker, and carried by the fallowing vote: "AYE" - Sam H. Kerr, C. F. Becker, A. M. Walker, W. A. Behannon and Kenneth Hoskins. "NO"- None. Carried, Ordinance placed on first reading.

Commissioner C. F. Becker moved that the ordinance pass first reading; seconded by Commissioner Kenneth Hoskins, and carried by the following vote:
"AYE"- Sam H. Kerr, C. F. Becker, A. M. Walker, W. A. Behannon, Kenneth Hoskins. "NO"- None. Carried; Ordinance passed first reading.

Commissioner W. A. Behannon moved that the rudes he suspended and that the ordinance be placed on second reading; seconded by A. M. Walker, and carried by the following vote: - "AYE" - Sam H. Kerr, C. F. Becker, A. M. Walker, W. A. Behannon and Kenneth Hoskins. "NO" - None. Carried; ordinance placed on second reading.

Commissioner Kenneth Hoskins moved that the ordinance pass second reading; seconded by C. F. Becker, and carried by the following vote: "AYE"- Sam HL Kerr, C. F. Becker, A. M. Walker, W. A. Behannon and Kenneth Hoskins. "NO" None. Carried; ordinance passed second reading. Mayor, Sam H. Kerr, then declared the ordinance finally passed. The ordinance appears of record elswhere in these minutes.

be made, and to promise said petitioners that such petition would be given consideration at the phoper time. Motion carried unanimously.

O. SAT-TERWHITE XNEXWIFEXEX UPON THE SAID J. O. SATTERWHITE AND WIFE EXECUTING TO THE CITY A DEED COVERING A LIKE QUANTITY OR PORTION FOR STREET PUR-POSES ON THE WEST SIDE OF RAGUET STREET WHERE IT INTERSECTS WEINER STREET. was presented for passage and approval.
