

MINUTES OF A CALL MEETING  
OF THE CITY COMMISSION OF THE CITY OF  
LUFKIN, TEXAS, HELD AUG.  
16th. 1927.

Be it remembered that on this the 16th day of August, A. D. 1927, there was begun and helden a call meeting of the City Commission of the City of Lufkin, Texas, at the City Hall in said City; Present and presiding the following officers of the City: J. W. Hawkins, Mayor, A. M. Walker, Commissioner of Ward No. 2, M. C. Spivey, Commissioner of Ward No. 3 and E. W. Leach, Commissioner of Ward No. 4, (Joe C. Denman, Commissioner of Ward No. 1, absent), V. R. Smitham, City Manager, W. O. Seale, City Attorney and T. L. Dunn, being present also, when the following proceedings were had, to-wit:-

Pursuant to the call of the Mayor as shown by the written call herein, the City Commission met for the purpose of declaring the result of an election held on the 9th day of August, 1927 for the purpose of amending the City Charter of said City and for the purpose of determining whether the City of Lufkin, Texas, should issue its bonds for the purpose of building a fire station, an incinerator, improve the sewer system, improve the waterworks system and improve the streets, and such other business as might properly come before the body.

J. L. Anderson and H. M. Bevel appears as representatives and made an appeal for financial aid for the purpose of erecting a memorial to the memory of the boys who died or was killed in the world war. The matter was discussed but no final action was taken regarding same; a promise was made however, that a contribution would be made at the proper time.

AN ORDINANCE CANVASSING THE RETURNS AND DECLARING THE RESULT OF AN ELECTION HELD WITHIN AND FOR THE CITY OF LUFKIN, TEXAS, ON THE 9th DAY OF AUGUST, A.D. 1927, TO DETERMINE WHETHER OR NOT THE CITY OF LUFKIN SHALL ISSUE ITS COUPON BONDS FOR THE SUM OF \$20,000.00 FOR THE PURPOSE OF PURCHASING A SITE AND CONSTRUCTING THEREON AN INCINERATOR FOR SAID

CITY OF LUFKIN; TO DETERMINE WHETHER OR NOT THE SAID CITY SHALL ISSUE ITS COUPON BONDS FOR THE SUM OF \$29,000.00 FOR THE PURPOSE OF PURCHASING A SITE AND CONSTRUCTING THEREON A ~~TRANSMISSION~~ FOR SAID CITY OF LUFKIN; TO DETERMINE WHETHER OR NOT THE SAID SHALL ISSUE ITS COUPON BONDS FOR THE SUM OF \$50,000.00 FOR THE PURPOSE OF IMPROVING THE SEWER SYSTEM OF SAID CITY OF LUFKIN; TO DETERMINE WHETHER OR NOT THE SAID CITY SHALL ISSUE ITS COUPON BONDS FOR THE SUM OF \$85,000.00 FOR THE PURPOSE OF IMPROVING THE WATER WORKS SYSTEM OF SAID CITY OF LUFKIN AND TO DETERMINE WHETHER OR NOT SAID CITY SHALL ISSUE ITS COUPON BONDS FOR THE SUM OF \$125,000.00 FOR STREET IMPROVEMENT PURPOSES IN SAID CITY OF LUFKIN, was presented for passage and approval on first reading. Said ordinance was passed on first reading as appears from the minutes elsewhere herein.
