when the following proceedings were had, to-wit:-

Minutes of former meetings read, and on motion duly made and carried, were approved as read.

An ordinance entitled "AN ORDINANCE PRESCRIBING THE TAXES TO BE LEVIED, ASSESSED AND COLLECTED BY THE CITY OF LUFKIN, TEXAS, FOR THE YEAR 1932, AND FOR EACH YEAR THEREAFTER UNTIL OTHERWISE PROVIDED" was presented for passage and approval on first reading. After reading said ordinance and considering same, it was moved by C. A. Burke and seconded by W. O. Greene that said ordinance be placed on first reading, and that same be passed and approved on first reading. The Mayor put the question and the following is the recorded vote on the proposition, to-wit: "AYES"- Wm. A. Foster, W. O. Greene, C.A. Burke, M. M. Jones and W. A. Abney,- "NOES"- None.- Whereupon the mayor declared the motion carried and said ordinance passed and approved on first reading.

An ordinance entitled "AN ORDINANCE REPOINTING THE MEMBERS OF THE BOARD OF EQUALIZATION IN AND FOR THE CITY OF LUFKIN, TEXAS, FOR THE YEAR A^dD^y. 1932", was presented for passage and approval on first reading. After reading said ordinance and considering same, it was moved by C. A. Burke and seconded by W. A. Abney, that said ordinance be placed on first reading and that it pass first reading. The Mayor put the question and for the following is the recorded vote on the proposition, to-wit:+ "AYES"- Wm. A. Foster, W. O. Greene, C. A. Burke, M. M. Jones, and W. A. Abney.- "NOES"- None. Whereupon the Mayor declared the motion carried and the said ordinance passed and approved on first reading.

It appearing that lights had been installed at the City park, and that it was necessary to enter into a contract with the Texas Power & Light Company to furnish current for said lights, it was moved by C. A. Burke and seconded by W. A. Abney that the Mayor of the City of Lufkin, Texas, be authorized to execute in the name of the City of Lufkin, Texas, a contract with said Texas Power and Light Company for sufficient current to provide necessary lights etc for the use of the City at the City Park, such contract as relating to price to be paid to be exactly the same terms as the present street lighting contract. The Mayor put the question and the said motion carried unanimoysly, and the Mayor is so authorized as aforesaid.
