

MINUTES OF REGULAR MEETING OF THE CITY COMMISSION
OF THE CITY OF LUFKIN, TEXAS, HELD SEPTEMBER 3,
1957, at 7:30 P. M.

On this the 3rd. day of September, A. D., 1957,
the City Commission of the City of Lufkin, Texas, convened in
regular session, in the regular meeting place in said

the following business was transacted:

1. Divine guidance of the meeting was invoked through prayer by Mayor S.R. Parker, Jr.
2. The minutes of the regular meeting of August 20, were read and approved.
3. A committee composed of Cliff Estes, Mrs. John Mason, and Judge Edward McFarland appeared in the interest of widening North Raguet Street. After discussing the matter it was agreed to get an estimate of the cost of such widening and paving, by Lloyd Moore, and then the matter would be further considered by the City and the abutting property owners. It was agreed to get an estimate of the cost of such paving and widening from Commerce Street to Abney Avenue, and then from Abney Avenue to the City limits.
4. The Commission approved payment of bill dated August 8, 1957, of Freeze, Nichols and Turner in the sum of \$3,362.92.
5. The Commission approved the agreement with citizens along the Harmony Hill Road, for the Harmony Hill water line.
6. The City Manager submitted map showing the proposed corrected drainage of the Tanglewood Addition from Jefferson Avenue to Marcus Avenue, and thence to the Creek.
7. The weed cutting ordinance was passed on first reading.
8. It was voted by the Commission not to have special or called meetings unless there was an emergency.

9. Zone application of Glenn Franks to change the zone from "B" District to "F" District on Lot Number One (1), Block Thirty Four (34) of the Denman Addition was passed on first reading.

10. The City Manager outlined a plan for one-way traffic~~s~~ around the Courthouse Square. One way traffic for First, Second and Third Streets was also discussed. The Commission voted to put into effect one-way traffic~~s~~ on such Streets, as soon as same could be worked out.

11. There being no further business to come before the Commission, the meeting adjourned.
