

MINUTES OF A CALL MEETING OF
THE CITY COMMISSION OF THE CITY
OF LUFKIN, TEXAS, HELD MAY 18th
1937.

Be it remembered that on this the 18th day of May, A. D. 1937, there was begun and holden a call meeting of the City Commission of the City of Lufkin, Texas, at the Municipal Office in said city with the following officers of the City present and presiding, to-wit:

was absent, account of being out of the City.

The following proceedings were had, to-wit:-

Mr. A. Stroud, was present and made a plea for the city to construct a six inch sewer line to run easterly from the "White Spot" to second street. The matter was discussed and City Manager was instructed to build such a sewer to within fifty feet of the "White Spot" building.

An Ordinance entitled "AN ORDINANCE REGULATING ANY CAMP OR TEMPORARY PLACE OF ABODE IN TENTS, WAGONS, VANS, AUTOMOBILES, CARAVANS OR GYPSY WAGONS, UNLESS THE LOT OR PARCEL OF LAND IS PROVIDED WITH SUITABLE SEWERAGE AND WATER SUPPLY FACILITIES, FOR A LONGER PERIOD THAN TWENTY FOUR (24) HOURS, AND PROVIDING A PENALTY FOR A VIOLATION OF ANY OF ITS PROVISIONS"

was introduced for passage and approval on second and final reading. Lewis Hicks made a motion that said ordinance be placed on second and final reading and that it be passed and approved on second and final reading. The motion was seconded by J. E. Jay. The Mayor put the question and the following is the recorded vote on the motion: "AYES"- Kenneth Hoskins, W. D. Winston, Jr., Lewis Hicks and J. E. Jay. "NOES"- None- Whereupon the Mayor declared the motion carried and the ordinance passed and approved on second and final reading.

Bids having been called for on the purchase of an Automobile for the Chief of the Fire Department, (Fire Chief's Car) the following were received:

Each bid being fairly considered, it was moved by W. D. Winston, Jr., and seconded by J. E. Jay, that the contract be awarded to Berry Motor Co. the lowest bidder. The Mayor put the question and the motion carried unanimously.
