COMMISSION OF THE CITY OF LUFKIN,  
TEXAS, HELD JUNE 4th, 1935.

there was begun and holden a regular meeting of the City Commission  
of the City of Lufkin, Texas, at the Municipal Office in said City

The following proceedings were had, to-wit:-

Minutes of all meetings held during the month of May, were read  
and on motion duly made and carried were approved as read.

The question of renewing a note of Earl M. Denman, representing  
the cash difference due by him in the sale of a certain eight wheel  
Marian Log Wagon. On motion duly made and carried it was ordered that  
renewal be granted, for a period of 90 days.

An ordinance entitled "AN ORDINANCE PRESCRIBING THE TAXES TO BE  
LEVIED, ASSESSED AND COLLECTED BY THE CITY OF LUFKIN, TEXAS, FOR THE  
YEAR 1935, AND FOR EACH YEAR THEREAFTER UNTIL OTHERWISE PROVIDED" was  
introduced for passage and approval on first reading. It was moved  
by Louis Hicks, and seconded by W. A. Abney that said ordinance be  
placed on first reading and that it be passed on first reading. The  
motion was put by the Mayor Pro Tem and the following is the recorded  
vote on the motion: "Ayes"- W. O. Greene, Louis Hicks, and W. A. Abney.  
"Noes"- None. Whereupon the Mayor declared the motion carried and the  
said ordinance passed on first reading.

An ordinance entitled "AN ORDINANCE APPOINTING THE MEMBERS OF THE  
BOARD OF EQUALIZATION IN AND FOR THE CITY OF LUFKIN, TEXAS, FOR THE  
YEAR A.D. 1935" was presented for passage and approval on first read-  
ing. It was moved by W. A. Abney and seconded by Louis Hicks, that  
said ordinance be placed on first reading and that it pass first read-  
ing. The Mayor put the question and the following is the recorded vote  
on the motion: "Ayes"- W. O. Greene, Louis Hicks and W. A. Abney. "Noes"-  
None. Whereupon the Mayor Pro Tem declared the motion carried and the  
said ordinance passed and approved on first reading.

An ordinance entitled "AN ORDINANCE TO ESTABLISH THE OFFICE OF ELECTRICAL INSPECTOR IN AND FOR THE CITY OF LUTKIN, TO REGULATE AND DEFINE THE DUTIES OF SUCH OFFICE AND TO ESTABLISH RULES AND REGULATIONS CONCERNING THE INSTALLATION, OPERATION AND MAINTENANCE OF ELECTRIC WIRING AND APPARATUS, TO FIX PENALTIES FOR THE VIOLATION OF ITS PROVISIONS AND REPEALING ALL LAWS IN CONFLICT THEREWITH, PROVIDING FOR PERMIT FEES, FOR THE INSPECTION THEREOF, AND LICENSING ELECTRICIANS" was introduced for pas-

sage and approval on first reading. It was moved by Louis Hicks and seconded by W. A. Abney that said ordinance be placed on first reading, and that it be passed on first reading. The Mayor put the question and the following is the recorded vote on the motion: "Ayes"-- W. O. Greene, Louis Hicks and W. A. Abney. "Noes"-- None. Whereupon the Mayor Pro Tem declared the motion carried and the said ordinance passed and first reading.

A PROCLAMATION IN PROPER form, declaring and Proclaiming the week June 10th to 15th. 1935 inclusive as "Railroad Week" was introduced for passage and approval. It was moved by Louis Hicks and seconded by W.A. Abney that said proclamation be passed and approved. The following is the recorded vote on the motion: "Ayes"-- W. O. Greene, Louis Hicks, and W. A. Abney. "Noes"-- None. Whereupon the Mayor Pro Tem declared the motion carried and the said proclamation passed and approved. (See another page of these minutes for a record of the proclamation".)
