1. Meeting was called to order by Mayor Louis Bronaugh.

## 2. CANVASS OF ELECTION RESULTS

Mayor Bronaugh stated that the City Commission had met to canvass the results of the Regular City Election held Saturday, May 5, 1990 for Wards 5 and 6.

Election of May 5, 1990, have been canvassed and that Jack Gorden be declared as Commissioner of Ward No. 5 and that Paul Mayberry be declared as Commissioner of Ward No. 6. A unanimous affirmative vote was recorded.

Mayor Bronaugh administered the oath of office to Jack Gorden as Commissioner of Ward No. 5 and to Paul Mayberry as Commissioner of Ward No. 6.
