MINUTES OF A CALLED MEETING OF
THE CITY COMMISSION OF THE CITY OF LUFKIN,
TEXAS, HELD SEPTEMBER 10th, 1925.

Be it remembered that on this the 10th day of September, A. D. 1925,
there came on and was held a call meeting of the honorable City Commis-
sion of the City of Lufkin, Texas, in the City Hall of said City, there
being present and presiding the following officers: J. W. Hawkins, Mayor,
Joe C. Denman, Commissioner of Ward No. 1, A. M. Walker, Commissioner of
Ward No. 2, W. A. Behannon, Commissioner of Ward No. 3, E. W. Leach, Com-
missioner of Ward No. 4, C. N. Humason, City Manager, W. O. Seale, City
Attorney and T. L. Dunn, City Secretary, when the following proceedings
were had, to-wit:-


The mayor stated that the purpose of the meeting was to consider
the adoption of the Annual Budget of the City for the year, beginning
April 1st, 1925 and ending March 31st, 1926, and to transact any other
business that may properly come before the meeting:-

Came on for consideration the matter about the land at the Old
City Pond which is in controversy with J. C. Smith, settled viz:-
37/100 acres of land heretofore bought from A. J. Vinson by Deed re-
corded in volume 10 page 553 of the Deed records of Angelina County,
Texas; also the city's easement or rights to a certain 1 acre of land
secured by condemnation proceedings from A. J. Vinson, all sold to the
said J. C. Smith for a consideration of \$100.00, payable viz:- \$25.00
cash and \$25.00 every 60 days with interest at the rate of 6% per an-
num, and the Mayor is hereby authorized to execute deed in the name of
the City according to the terms as above set out.

The Budget as heretofore prepared and published was adopted with
additions as follows:- \$90.00 for Booster Band and \$100.00 for City
Recorder. A copy of said budget appears hereon, viz:-



On motion by A. M. Walker seconded by E. W. Leach, Estimate No. 2 to J. S. Moore and Sons on sewer construction contract was allowed in the sum of \$12,749.84.

On motion by A. M. Walker and seconded by Joe C. Denman the monthly allowance due Fred A. Jones, Engineer, on water and sewer construction was allowed in the sum of \$311.82.

On motion made by A. M. Walker, seconded by Joe C. Denman the City Manager was instructed to place order for Coke for water purifying plant.

There being no further business to come before the meeting, by move and second duly made and carried, same adjourned.
