1. The meeting was opened with prayer by Reverend William Ricks, First Missionary Baptist Church.
2. Mayor Jack Gorden welcomed visitors present. Councilmember Lynn Torres recognized LHS student Travis Chesser, who was present satisfying his government class requirement.
3. **APPROVAL OF MINUTES**

Minutes of the Regular Meeting on April 3, 2007 were approved on a motion by Councilmember Lynn Torres, and seconded by Councilmember Rose Faine Boyd. A unanimous affirmative vote was recorded.

OLD BUSINESS:

4. **SECOND READING OF AN ORDINANCE AMENDING THE ZONING ORDINANCE AND THE FUTURE LAND USE PLAN OF THE 2001 COMPREHENSIVE PLAN OF THE CITY OF LUFKIN, TEXAS, - APPROVED - CHANGING THE ZONING AND FUTURE LAND USE PLAN DESIGNATION ON APPROXIMATELY .75 ACRES OF LAND DESCRIBED AS TRACT 217 OF THE L. HOLLOWAY SURVEY, ABSTRACT 310 AND TRACT 104.1 OF THE H. H. BROOKSHIRE SURVEY, ABSTRACT 127 TO COMMERCIAL ZONING DISTRICT AND THE FUTURE LAND USE PLAN OF THE 2001 COMPREHENSIVE PLAN TO THE CLASSIFICATION OF COMMERCIAL**

Mayor Jack Gorden stated that the next item for consideration was a Public Hearing and the Second Reading of an Ordinance amending the Zoning Ordinance and the Future Land Use Plan of the 2001 Comprehensive Plan of the City of Lufkin, Texas, by changing the Zoning and Future Land Use Plan Designation on approximately .75 acres of land described as Tract 217 of the L. Holloway Survey, Abstract 310 and Tract 104.1 of the H. H. Brookshire Survey, Abstract 127 to Commercial Zoning District and the Future Land Use Plan of the 2001 Comprehensive Plan to the classification of Commercial.

City Manager Paul Parker stated this was the Second Reading of the Ordinance and that Staff would answer any questions that Council had regarding the item. City Manager Parker added that this was a request for commercial zoning to allow Ms. Hulett to build a Day Care at the location

Mayor Jack Gorden opened the Public Hearing at 5:12 p.m.

Mayor Gorden closed the Public Hearing at 5:13 p.m.

Councilmember Don Langston moved to approve the Second Reading of the Ordinance amending the Zoning Ordinance and the Future Land Use Plan of the 2001 Comprehensive Plan of the City of Lufkin, Texas, by changing the Zoning and Future Land Use Plan Designation on approximately .75 acres of land described as Tract 217 of the L. Holloway Survey, Abstract 310 and Tract 104.1 of the H. H. Brookshire Survey, Abstract 127 to Commercial Zoning District and the Future Land Use Plan of the 2001 Comprehensive Plan to the classification of Commercial. Councilmember Rose Faine Boyd seconded the motion. A unanimous affirmative vote was recorded.

TABLED BUSINESS:

5. AUTHORIZE TAC AMERICAS, INC. TO PERFORM AN ENERGY AUDIT - APPROVED - FOR THE CITY OF LUFKIN

Mayor Jack Gorden stated that the next item for consideration was authorizing TAC Americas, Inc. to perform an energy audit for the City of Lufkin

City Manager Paul Parker stated that Staff sent out RFQs for an energy audit of the City's buildings, primarily City Hall, the Library, the Civic Center, Animal Shelter, Solid Waste, and Fire Stations to determine if there was indeed energy savings. City Manager Parker added that these savings could be from retrofitting lighting and other improvements to the physical plans of these facilities to save in the long term on electrical rates. City Manager Parker stated that Staff recommended TAC Americas, Inc. to the Council for consideration, based on their qualifications. City Manager Parker added that the firm did a preliminary audit of the City and determined that through retrofits the City could save approximately one hundred twenty thousand dollars (\$120,000) annually. City Manager Parker stated that the next step would be the City would enter into a contract with TAC Americas, Inc. to do a detailed audit in the amount of twenty-eight thousand five hundred dollars (\$28,500). City Manager Parker explained that if the audit proved that there was indeed savings through the funding process for electrical renovations, then TAC Americas, Inc. would underwrite or guarantee the savings. City Manager Parker added that if the City of Lufkin did not receive the guaranteed savings identified in the plan then TAC Americas, Inc. would make up the difference in the shortfall.

City Manager Parker stated that the Council had previously questioned about how to measure the project and determine the value and savings that were promised. City Manager Parker added that the Council asked what would be the benchmarks to begin the process to ensure that the dollar amount of savings were based on justifiable numbers and not just changing the hours of operation. City Manager Parker stated that a sub-committee made up of Mayor Gorden, Councilmember Langston, Assistant City Manager Keith Wright and City Manager Paul Parker met with representatives of TAC Americas, Inc. to discuss the project in great detail. City Manager Parker stated that the sub-committee's consensus was that there were good benchmarks to measure the improvements or electrical savings and

believed that the savings were available to the City of Lufkin. City Manager Parker stated that after the detailed audit was completed and should the Council decided not to go forth, the City of Lufkin would reimburse TAC Americas, Inc. the twenty-eight thousand five hundred dollars (\$28,500) for the study. City Manager Parker added that if the Council decided to go forth then that money would be rolled into the overall guarantee and overall project. City Manager Parker explained that TAC Americas, Inc. would then develop bids and specifications and have the work completed for whatever the Council approved. City Manager Parker stated that based on the review of the sub-committee the Staff recommended to the Council that the City of Lufkin enter into a contract with TAC Americas, Inc. to perform an energy audit for the City of Lufkin with a maximum exposure of twenty-eight thousand five hundred dollars (\$28,500).

Councilmember R. L. Kuykendall moved to approve authorization of TAC Americas, Inc. to perform an energy audit for the City of Lufkin. Councilmember Lynn Torres seconded the motion. A unanimous affirmative vote was recorded.

NEW BUSINESS :

6. **RECOGNITION TO THE MUSEUM OF EAST TEXAS, - APPROVED - AND FURTHER URGING ALL THE CITIZENS OF LUFKIN TO BE COGNIZANT OF THE MANY CONTRIBUTIONS OF THE MUSEUM AND ITS FOUNDERS**

Mayor Jack Gorden stated that the next item was to recognize the Museum of East Texas, and further urging all the citizens of Lufkin to be cognizant of the many contributions of the Museum and its founders. Mayor Gorden stated that the City of Lufkin was presenting a Proclamation to the Museum of East Texas and asked the Executive Director of the Museum J. P. McDonald to introduce the honorees. Mayor Gorden stated that the City was thankful that Jane Cornelius, Joan Duncan, Jan Osgood, Velma Reese, Nancy Reilly, Sally Selman, and Emily Shelton could be in attendance.

Mayor Gorden then read the Proclamation recognizing the Museum of East Texas. Mayor Gorden added that the City wanted to extend its heartfelt thank you to the ladies who founded the Museum of East Texas. Mayor Gorden then asked for comments from those present.

Nancy Reilly stated, "She remembered what her mother always said, "that you could get a lot done if you don't care who gets the credit" and that this was how the Lufkin Service League operated".

Joan Duncan stated that she appreciated all the City had done and that all had worked hard and that she thanked the City for its support.

Emily Shelton stated that it was an adventure because they started with the burned out St. Cyprian's Church. Ms. Shelton added that it was a very dirty and difficult job but they thought that they had enriched the lives of the children in Lufkin and that was the important thing.

Executive Director J. P. McDonald stated that she wanted to recognize all those attending the meeting for their invaluable service and the children and their families and encouraged everyone to visit the museum often.

Mayor Gorden then asked all those associated with the Museum of East Texas to stand and be recognized.

Councilmember R. L. Kuykendall commented that the Museum of East Texas was a wonderful facility in the City of Lufkin. Councilmember Rose Faine Boyd added that she appreciated everything that the Museum did for the community and would continue to ask people to visit the museum. Councilmember Don Langston stated that he thought it would be interesting if J. P. McDonald would prepare the legacy that the ladies had left to the Museum of East Texas and to the community. Councilmember Langston added that it was a great example to the youth for them to understand the importance of them taking a part in

their community and helping their community grow and prosper and that the museum had certainly done that he was glad to have it in Lufkin.

Councilmember Rufus Duncan moved to approve the Proclamation recognizing the Museum of East Texas, and further urging all the citizens of Lufkin to be cognizant of the many contributions of the Museum and its founders. Councilmember Rose Faine Boyd seconded the motion. A unanimous affirmative vote was recorded.

7. PROCLAIMING THE MONTH OF APRIL AS FAIR HOUSING MONTH - APPROVED - FOR THE CITY OF LUFKIN

Mayor Jack Gorden stated that the next item was to proclaim the month of April as Fair Housing Month for the City of Lufkin.

City Manager Paul Parker stated that April was designated as "Fair Housing Month" and the Proclamation would allow the City of Lufkin to recognize the National Fair Housing Law during the month of April in the City of Lufkin. City Manager Parker added that Staff recommended that the City Council approve the Proclamation designating April as Fair Housing Month for the City of Lufkin.

Councilmember Rose Faine Boyd moved to proclaim the month of April as Fair Housing Month for the City of Lufkin. Councilmember Phil Medford seconded the motion. A unanimous affirmative vote was recorded.

8. FIRST READING OF AN ORDINANCE AMENDING THE ZONING ORDINANCE AND THE COMPREHENSIVE PLAN 2001 OF THE CITY OF LUFKIN, TEXAS - APPROVED - BY ESTABLISHING ZONING AND FUTURE LAND USE PLAN DESIGNATIONS FOR LAND WHICH IS 148 ACRES LOCATED NEAR EAST LOOP 287 BETWEEN HWY 103 EAST AND OLD MOFFETT ROAD AND ANNEXED BY ORDINANCE NUMBER 3968 AND AUTHORIZING THE CITY PLANNER TO MAKE SUCH CHANGES ON THE OFFICIAL MAPS

Mayor Jack Gorden stated that the next item for consideration was the Public Hearing and the First Reading of an Ordinance amending the Zoning Ordinance and the Comprehensive Plan 2001 of the City of Lufkin, Texas by establishing Zoning and Future Land Use Plan Designations for Land which is 148 Acres located near East Loop 287 between HWY 103 East and Old Moffett Road and Annexed by Ordinance Number 3968 and authorizing the City Planner to make such changes on the Official Maps.

City Manager Paul Parker stated that at the last Council Meeting the property was annexed into the City of Lufkin and would need zoning. City Manager Parker added that the Industrial Park that was purchased through the 4B Economic Development and the City and was recommended to be zoned for industrial usage. City Manager Parker explained that the commercial on the frontage (as was indicated on the map attached in the Council's packets) was extended to the rear portion of the property that was annexed. City Manager Parker stated that Staff had contacted all of the property owners and there was no one present at the Planning and Zoning Commission Meeting and that there had been no opposition filed. City Manager Parker added that the Planning and Zoning Commission and Staff recommended that the proposed Zoning by unanimous vote.

Mayor Jack Gorden opened the Public Hearing at 5:30 p.m.

Mayor Gorden closed the Public Hearing at 5:31 p.m.

Councilmember Rufus Duncan moved to approve the First Reading of an Ordinance amending the Zoning Ordinance and the Comprehensive Plan 2001 of the City of Lufkin, Texas by establishing Zoning and Future Land Use Plan Designations for Land which is 148 Acres located near East Loop 287 between HWY 103 East and Old Moffett Road and Annexed by Ordinance Number 3968 and Authorizing the City Planner to make such changes on the Official Maps. Councilmember Don Langston seconded the motion. A unanimous affirmative vote was recorded.

9. FORMAL ACCEPTANCE OF ALL ASBESTOS CEMENT WATERLINE REPLACEMENTS - APPROVED - COMPLETED BY THE CITY OF LUFKIN

Mayor Jack Gorden stated that the next item for consideration was the formal acceptance of all Asbestos Cement Waterline Replacements completed by the City of Lufkin.

City Manager Paul Parker stated that Project 8A had been completed and that the City had to begin Crown Colony to be started on the last of the waterline replacement.

Assistant City Manager Keith Wright stated that there were four (4) more waterline replacement projects to finalize. City Manager Parker added that all of the projects were in the final stages with the exception of Crown Colony. City Manager Parker stated that the formal acceptance authorized the project known as Project 8A which was State Highway 103 and Paul Avenue. City Manager Parker stated that the final payment to J and D Construction would be twenty-three thousand nine hundred seventy-two dollars and ninety-nine cents (\$23,972.99) for a total project cost of four hundred seventy-nine thousand four hundred fifty-nine dollars and eighty-one cents (\$479,459.81). City Manager Parker added that all of improvements were completed in accordance with the specifications and that Staff recommended that Council accept Project 8A and authorize the final payment.

Councilmember Lynn Torres moved to approve the formal acceptance of all Asbestos Cement Waterline Replacements completed by the City of Lufkin. Councilmember Rose Faine Boyd seconded the motion. A unanimous affirmative vote was recorded.

10. FIRST READING OF AN ORDINANCE AMENDING THE TRAFFIC ORDINANCE OF THE CITY OF LUFKIN, TEXAS; - APPROVED - PROVIDING FOR A CHANGE IN THE SPEED LIMIT ON WHITEHOUSE DRIVE, TULANE DRIVE, PERSHING AVENUE, MARTIN LUTHER KING DRIVE, AND PAUL AVENUE; AND REPEALING ALL INCONSISTENT ORDINANCES AND ESTABLISHING AN EFFECTIVE DATE

Mayor Jack Gorden stated that the next item for consideration was the First Reading of an Ordinance amending the Traffic Ordinance of the City of Lufkin, Texas; providing for a change in the speed limit on Whitehouse Drive, Tulane Drive, Pershing Avenue, Martin Luther King Drive, and Paul Avenue; and repealing all inconsistent ordinances and establishing an effective date.

City Manager Paul Parker stated that Staff had been studying the existing streets and that some had been improved over the last year. City Manager Parker added that after assessing the existing speed limits it was determined that the speed limits needing adjusting City Manager Parker stated that most of the streets would be authorized by the study to be forty-five miles per hour (45 mph) but Staff felt that in their recommendations that going from thirty miles per hour (30 mph) to forty-five miles per hour (45 mph) might be excessive at the time. City Manager Parker stated that at thirty miles per hour (30 mph) the average speed was over forty-five miles per hour (45 mph). City Manager Parker added that Staff felt that it was necessary to raise the speed limits but were recommending forty miles per hour (40 mph) speed limit on Whitehouse Street from the intersection of Tulane Drive and Whitehouse Street to FM Highway 58 (Chestnut Drive) for both directions.

City Manager Parker stated that on Tulane Drive from intersection of FM 1877 (Harmony Hill Drive) and Tulane Drive to the intersection of Darlington Street and Tulane Drive, the speed limit would be forty miles per hour (40 mph) in either direction and the area within the residential section would remain as it is now which is thirty miles per hour (30 mph).

City Manager Parker stated that Pershing Avenue from the intersection of Castlewood Circle and Pershing Avenue to the intersection of Loop 287 (South John Redditt Drive) and Pershing Avenue, the speed limit would be forty miles per hour (40 mph) in either direction. City Manager Parker added that currently the speed limit was forty miles per hour (40 mph) one direction and thirty miles per hour (30 mph) the other direction.

City Manager Parker stated that Martin Luther King Drive from four hundred fifty feet (450') north of the intersection of F W Thomas Drive and Martin Luther King Drive to the intersection of Loop 287 (Ellen Trout Drive) and Martin Luther King Drive the speed limit would be forty miles per hour (40 mph) in either direction.

City Manager Parker stated that Paul Avenue from the intersection of Lubbock Street and Paul Avenue to the intersection of Loop 287 (North Medford Drive) and Paul Avenue, the speed limit would be forty miles per hour (40 mph) in either direction.

City Manager Parker stated that Staff recommended the changes to the Council for their consideration.

Councilmember Don Langston asked if the City Staff could look at Ford Chapel because there was a thirty miles per hour (30 mph) speed limit going one direction and forty miles per hour (40 mph) going the other direction. Assistant City Manager Keith Wright explained that it was a State highway and that the City could request that the State analyze that area.

Councilmember Rose Faine Boyd moved to approve the First Reading of an Ordinance amending the Traffic Ordinance of the City of Lufkin, Texas; providing for a change in the speed limit on Whitehouse Drive, Tulane Drive, Pershing Avenue, Martin Luther King Drive, and Paul Avenue; and repealing all inconsistent ordinances and establishing an effective date. Councilmember Lynn Torres seconded the motion. A unanimous affirmative vote was recorded.

11. APPROVAL OF INCREASE - APPROVED - OF ELLEN TROUT ZOO ADMISSION FEES

Mayor Jack Gorden stated that the next item for consideration was the approval of increase of Ellen Trout Zoo admission fees.

City Manager Paul Parker stated that at a recent planning retreat the Council had discussed the expansion needs of Ellen Trout Zoo and particularly looked at an education and administrative facility, a great ape exhibit, as well as expanded needs and renovation that is ongoing throughout the Zoo at all times. City Manager Parker explained that this generated a need for additional revenue. City Manager Parker added that the Zoo was by far one of the best bargains in the area and that even with the proposed increase would still remain the best value in the area.

City Manager Parker stated that the proposed fee structure would increase general adults (12-up) from \$3.00 to \$5.00; general child (4-11 years) from \$1.50 to \$2.50; group adult from \$1.50 to \$2.50; group child from \$.75 to \$1.25; school from \$.50 to \$1.00; and children under four (4) would remain free of charge. City Manager Parker added that the City of Lufkin would continue to use the present policy of free admission on Sunday and Monday mornings before 10:00 a.m. City Manager Parker stated that "Friends of the Zoo" would continue to provide family memberships at a discount rate which would allow unlimited free admissions for members for one (1) year. City Manager Parker added that the membership could also be used at other zoos within the state that are part of the association. City Manager Parker stated that there were several avenues that would make visiting the Ellen Trout Zoo an affordable event.

Councilmember Phil Medford moved to approve the increase of Ellen Trout Zoo admission fees. Councilmember R. L. Kuykendall seconded the motion. A unanimous affirmative vote was recorded.

12. RESOLUTION AUTHORIZING AN AMENDMENT TO THE 2006/2007 OPERATING BUDGET (BUDGET AMENDMENT NO. 20), - APPROVED - PROVIDING FOR THE SUPPLEMENTAL APPROPRIATION OF FUNDS IN THE GENERAL DEBT SERVICE FUND; AND PROVIDING AN EFFECTIVE DATE

Mayor Jack Gorden stated that the next item for consideration was a Resolution authorizing an Amendment to the 2006/2007 Operating Budget (Budget Amendment No. 20), providing for the supplemental appropriation of funds in the General Debt Service Fund; and providing an effective date.

City Manager Paul Parker stated that this was a "clean up" Ordinance, due to the reissuing of bonds that was done earlier in the year. City Manager Parker added that it was for auditing purposes so that the budget would reflect the revisions through the refunding issue. City Manager Parker stated that there was no additional appropriation or additional allocation of funding by the Ordinance.

Councilmember Don Langston moved to approve a Resolution authorizing an Amendment to the 2006/2007 Operating Budget (Budget Amendment No. 20), providing for the supplemental appropriation of funds in the General Debt Service Fund; and providing an effective date. Councilmember Lynn Torres seconded the motion. A unanimous affirmative vote was recorded.

13. CITY MANAGER'S REPORT

Mayor Jack Gorden stated that the next item for consideration was the presentation of the City Manager's report.

City Manager Paul Parker stated that there was one thing that he did not mention on the Zoo agenda item. City Manager Parker explained that the fee increase was proposed for June 1st so that no school field trips would be impacted.

City Manager Parker stated that before the Council was the Project Status Report and wanted to highlight a couple of the projects. City Manager Parker stated that the City was still working with TXDOT on Whitehouse Phase III Extension. City Manager Parker stated that the Engineering Company had sent TXDOT another mock up but the mock ups were still in the local TXDOT office waiting to be sent to Austin. City Manager Parker explained that the City had wanted to expedite that project because it was tied into the Hwy 59 expansion. City Manager Parker added that it had drug on and had been complete and going through the process for approximately seven (7) to eight (8) months.

There was some discussion among Council and Staff concerning the Whitehouse Phase III Extension and problems encountered with TXDOT.

There was also discussion among the Council and Staff concerning the Daniel McCall Bridge Project and the Tulane Bridge Project.

City Manager Parker stated that the Lotus Lane Street Project was underway. City Manager Parker added that the Asbestos Waterline Replacement Project was proceeding on Champions Drive in Crown Colony.

Assistant City Manager Keith Wright stated that the Fire Station Project on Old Union was moving along and should have the building pad completed within the next couple of weeks.

Mayor Gorden thanked City Manager Parker for the Project Status Reports and added that the reports enable the Council to keep up with all of the projects going on in the City of Lufkin.

Councilmember Don Langston asked about a project in the report concerning the Video Viewing at Courthouse for District Attorneys and what was involved in the project and who was paying for the project. Assistant Police Chief Scott Marcotte stated that there were digital recording systems in the Police cars and the systems were set up so that both the County Attorney and the District Attorney's office could view those videos from their respective offices. Assistant Chief Marcotte added that currently the Police Department had a person that burns cds for the County Attorney and District Attorney offices. Assistant Chief Marcotte stated that burning the cds was time consuming. Assistant Chief Marcotte added that they could currently earmark video for both offices to view and if it was of value

to them in the prosecution of their case then it could be downloaded. Assistant Chief Marcotte explained that the Video Viewing Project would greatly enhance the Police Department's ability to get the evidence to the attorneys that is needed. Assistant Chief Marcotte stated that there were times when the attorneys needed evidence quickly and this Project would enable the Police Department to provide the evidence in a timely manner.

14. Mayor Jack Gorden recessed the Regular Session at 5:50 p.m. to enter into Executive Session.

EXECUTIVE SESSION: In accordance with the Texas Government Code Section 551.071 (2) Consultation with City Attorney on any Regular Session Agenda item requiring confidential, attorney/client advices necessitated by the deliberation or discussion of said items (as needed), and real estate, demolition of buildings, or appointments to boards and personnel may be discussed

Mayor Jack Gorden reconvened the Regular Session at 6:08 p.m.

15. **APPOINTMENTS TO DETCOG BOARD**

Mayor Jack Gorden stated that the next item for consideration was the appointments to the DETCOG Board.

Councilmember Lynn Torres moved to appoint Mayor Jack Gorden and Council Members Rose Faine Boyd, Don Langston, and R. L. Kuykendall to the DETCOG Board. Councilmember Rufus Duncan seconded the motion. A unanimous affirmative vote was recorded.

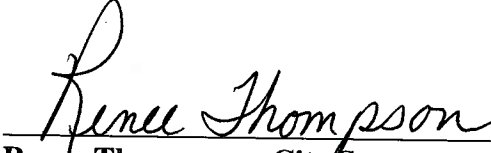
16. **CALENDAR NOTATIONS FROM MAYOR, COUNCIL MEMBERS, AND CITY MANAGER**
