

MINUTES OF REGULAR MEETING OF THE
CITY COMMISSION OF THE CITY OF LUFKIN,
TEXAS, HELD JANUARY 4th, 1921.

Be it remembered that on this the 4th day of January, A.D. 1921, there was begun and holden a regular meeting of the City Commission of the City of Lufkin, Texas, at the Municipal Office thereof in the City of Lufkin, Texas; Present and presiding the Hon. G. A. Kelley, Mayor, and S. R. Parker, Commissioner Ward No. 1, E. E. Woods, Commissioner Ward No. 2, B. L. Zeagler, Commissioner Ward No. 3 and W. B. Treadwell, Commissioner Ward No. 4 and J. O. Booker, City Manager and T. L. Dunn, City Secretary, when the following proceedings were had, to-wit:-

Minutes of Regular meeting held Dec. 7th, and Call meeting held Dec. 11th, read and approved.

-----oOo-----
The question of opening up new work on other streets in the City for paving was discussed, and it appearing that the streets now under way of paving should be finished before beginning work on others, it was moved By E. E. Woods and seconded by B. L. Zeagler that no more work be begun on paving of other streets until the ones, or at least a good portion of them, are finished. The question was put by the Mayor and each members of the City Commission voted "Aye" and the mayor declared said motion carried.

A general discussion of progress being made on street paving as well as other important matters pertaining to the general operation of city affairs was entered into by all members of the Board of Commissioners, and special instructions regarding collection of delinquent water customers was made, which were to proceed at once for the collection of same as prescribed by ordinance. It was also specially urged that efforts be made at once to improve the bad places in the streets of the city.

A resolution approving plans, specifications, profiles etc. filed by the City Engineer for the improvement of certain streets of the city was presented for passage and approval, which said streets to be improved are as follows:- Shepherd Avenue, Angelina Avenue, Second Street, Lufkin Avenue, Dozier Avenue, Paul Avenue and North First Street. B. L. Zeagler made a motion, which was seconded by W. B. Treadwell, that said resolution be passed. Upon the question being put by the Mayor, the following vote is recorded. S.R.Parker, voted "Aye, E. E. Woods Voted "Aye", B. L. Zeagler Voted Aye and W. B. Treadwell voted "Aye". No votes were against the proposition, whereupon the Mayor declared the motion carried, and the resolution passed, and same was ordered entered of record on the Minutes of the City Commission.

All claims due by the city to various parties, firms and corporations were presented for payment and at appearing that same had been properly approved by the City manager it was, by move and second, duly made and carried ordered that same be allowed and that City Warrants be issued in payment of same.

There being no further business to come before the meeting, by move and second duly made and carried, adjournment was taken.
