MINUTES OF Special MEETING OF THE CITY COMMISSION  
OF THE CITY OF LUFKIN, TEXAS, HELD May 19th  
1943 AT 4:00 P.M.

On this the 19th day of May, A. D. 1943,  
the City Commission of the City of Lufkin, Texas, convened in  
Special session, in the regular meeting place in said  
City, with the following members thereof, to-wit:

being present, and the following absent:

constituting a quorum when the following business was transacted;

1 Also present were Steve Harmon, S. W. Henderson, Jr., W. C. Binion, Ulen Medford, E. W. Leach and W. R. Beaumier as a committee from the Chamber of Commerce in the interest of passing an ordinance providing for the ordering of an election for determining whether a committee should be chosen for framing a new City Charter.

2 The ordinance was presented and passed on first and second readings, ordering the election to be held on August 10th 1943 and the ordinance in complete detail is attached and made part of these minutes.

3 Matter of repealing ordinance passed in 1940 regulating rates for natural gas in the City and accepting new rates offered at this time by United Gas Corporation was brought up and without formal action was delayed in order to give Mr. Kelley time to investigate the rates offered.

4 Attention was called to the fact that it was time to call for bids for depository for City funds and the City Secretary was instructed to proceed to advertise for bids.

5 Motion was made by B.F. Milligan, second by Arthur Temple, Jr., authorizing the City Manager to make contract for sale of City owned property on Denman Avenue for \$4,750.00 on terms of \$500.00 cash as earnest money with thirty days allowed for paying balance to complete the sale or forfeit the cash payment.

Motion carried by all members voting yea.

6 Motion by Arthur Temple, Jr., second by Jas. A. Abney and carried by all members voting yea, authorized the Mayor and City Secretary to execute deed to above property.

7 Motion by B.F. Milligan, second by Arthur Temple, Jr., carried by all members voting yea, authorized Mr. Kelley to sell the Pump and Motor that was removed from use in the water well at Redland for \$1,250.00 fob present location of material.

Nothing further was presented for attention and the meeting adjourned.
