- The meeting was opened with prayer by Mayor, S.R. Parker, Jr..
- The Minutes of the Regular Meeting held November 19th were read and approved.
- Bids were opened for the purchase of a motor grader and the following bids were read:

South Texas Equipment Company, Inc. of Houston, Texas, Adams Grader, \$18,031.00, with trade-in allowance on old grader \$3,031.00, net \$15,000.00, cash discount \$1,731.00;

Browning - Ferris Machinery Company of Houston, Galion Motor Grader, \$17,933.00, trade-in allowance on old grader, \$3,250.00, net, \$14,683.00, with no trade-in, five (5%) per cent discount;

Mustang Tractor and Equipment Company, Houston and Lufkin, Texas, Caterpillar, \$18,388.23, trade-in allowance, \$2,218.59, net \$16,169.64, two (2%) per cent cash discount, with no trade-in:

Highway Equipment Company of Houston, \$19,166.00, with Torque Converter \$20,392.00, trade-in allowance on old grader \$4,166.00.

It was agreed to postpone the awarding of the bid for purchase of such equipment until the regular meeting to be held December 17th, in order to give the City Manager an opportunity to study such bids and to see the various graders in action.

- 4. Bid was awarded to the Underwood Company for the purchase of two billing machines in the sum of \$6,976.70, this Company being the lowest and best bidder for such machines.
- 5. The City Manager was granted authority to purchase, at a price not to exceed \$800.00, a used pick-up truck for the Street Department, to be used by Mr. Burris to transport men and materials from job site to job site, in the City.
- 6. Upon the recommendation of the City Manager the old pool table at the Fire Station, the Commission voted to give such table to the YMCA.
- 7. The Ordinance changing the zoning designation on property on Lufkin Avenue was passed on first reading.
- 8. The City Manager reported that all property owners had signed deed for street dedication, on Trenton Street from Paul Avenue to Atkinson Drive.
- 9. The filling in of the storm sewer on the property belonging to Fenley and Musslewhite on Timberland Drive and Chestnut was discussed, but no action was taken. It was suggested that the City Manager write a letter to the said attorneys that the City could not make such a fill.
- 10. Their being no further business to come before the Commission the Meeting adjourned.
